BOYATT WOOD PARISH COMMUNITY SURVEY

Key Outcomes – February 2024

Introduction

Boyatt Wood Parish Council agreed in 2023 to undertake a community survey of residents, frequent visitors, businesses and their employees to the parish.

It was undertaken to help the Parish Council set parish priorities appropriate to the expectations of their electorate. Additionally, it will aid the council in understanding what the community expects of its Parish Council and if these expectations are realistic. For example, if the community reports a concern that the Parish Council holds no influence over, for example, highway issues, a need for education and information sharing could be indicated rather than action itself.

This consultation started on 9 September 2023 and closed on 31 December 2023. It ran for 16 weeks.

The questionnaire was circulated and publicised widely. This included:

- Leaflet drop to every property in the parish.
- Via the Parish Council website and Face Book.
- An article in Eastleigh news.
- Posters in prominent locations across the parish.
- Through events such as Eastleigh Pride 2023
- Via word of mouth by parish councillors, the parish clerk and others.
- Paper copies could be collected from St Peters Church.

The questionnaire could be completed in both electronic and paper forms.

A total of 353 completed questionnaires were received.

The following document provides a summary of the key findings.

Q1. What is your age group:

Question one related to the age of the respondent. The greatest number of responses, 28.6% (101), were received from those aged 35-49 years old. This was closely followed by 65–74-year-olds who comprised 27.5% (97) of the responses. The age band 50–64-year-olds made up 23.5% (83) of the replies.

Question two asked what sex the respondents were. 53.8% (190) stated their sex as being female and 44.5% (157) as male. Only 1.7% (6) respondents declined disclosure.

Question three on ethnic origin revealed an overwhelming majority of respondents, 94.6% (334), described their ethnic origin as white.

Question four gauged the health of the respondent. 72.5% (256) reported no health issues whilst 24.4% (86) said they had health issues expected to last more than 12 months.

Question five established what caring responsibilities the population of Boyatt Wood had. 77.3% (273) reported no caring responsibilities whilst 20.7% (73) did.

Q6. How long have you lived in Boyatt Wood?

Question six was included to see how long respondents had lived in the parish. Half of the respondents, 50.1% (177) had lived in the parish for more than 20 years, 17.3% (61) for more than 10 years and 17% (60) for between 6-10 years.

Question seven, which was voluntary, asked if the respondent identified with the same sex that they were registered with at birth. The overwhelming majority, 96% (340), reported they did identify as the same sex as registered at birth and 0.6% (2) did not. 3.1% (11) preferred not to say.

Q8. What is your postcode?

Question eight, which asked respondents what their postcode was, received 340 responses, with all the postcodes provided from the Boyatt Wood parish

area (i.e., all the "outward" postcodes start with S050 bar one which started with S053)

The main area of concern was '*parking on pavements/parking dangerously*' with 67.7% (236) of responses stating that they were concerned or very concerned about this. This was followed by '*speeding through the village*' with 65.5% (228) of responses stating that they were concerned or very concerned. Slightly more than half of respondents, 56.3% (196) were also concerned or very concerned about the volume of traffic in the parish.

Concerns regarding walking in the parish were expressed by just over half the respondents (52.6% or 184). Cycling in the parish and access to public transport were of concern to less than 50% of the respondent (47.7% and 47.3% respectively).

There were a further 146 open-ended responses to this question. This was, by a wide margin, the most open-ended responses received to any question.

There were four major, in some respects over-lapping, themes, here.

- The condition of the roads (and to a lesser extent cycleways and footpaths), especially addressing potholes.
- Poor and inconsiderate driving (not only in terms of cars but also escooters and cyclists).
- Closely related to the above, speeding.
- Car parking, not only in terms of inconsiderate parking especially in and around the primary school and other 'hot spots', but also the adequacy of its provision in some parts of the parish.

Several suggestions were made on how the transport network and situation in the parish could be improved.

Just over three-quarters (78.51% or 274) stated no when asked whether they would like to participate in a community speed watch scheme.

The most frequently cited option was '*Not running frequently enough*' with over half (54.5% or 158) mentioning this. This was followed by '*Not running at the times you need them to*' at 37.9% (110) and '*Does not go to the destination you need*', at 35.5% (103). The least frequently mentioned option was '*Accessibility of vehicle itself*' at 2.8% (8).

87 open-ended comments were received to this question. The dominant theme echoed the answers given in the survey, namely that the existing bus service was too unreliable and infrequent to offer a viable alternative transport option to the car.

Q12. How concerned are you about the following issues in Boyatt Wood?

In percentage terms, '*Litter/Fly Tipping*' was the biggest concern, with nearly three quarters of those who responded with 74.7% (or 251) stating Boyatt Wood Parish Council Community Survey – Key Outcomes Summary Report (February 2024)

that they were concerned or very concerned about this issue. This was closely followed by '*anti-social behaviour*' at 73.6% (or 251) stating that they were concerned or very concerned about this issue. Next came '*Burglary and Theft*' with 70.4% (240) stating that this was an issue of concern.

The least area of concern, and by a wide margin, was '*Nuisance Neighbours*' with 29.8% (102) stating that they were concerned or very concerned about this issue. This was also the only option where the percentage of those who stated that they were unconcerned or very unconcerned about this was greater than those who stated that they were concerned or very concerned.

33 open-ended responses were received to this question, including, in particular, concerns about inconsiderate parking, speeding and anti-social behaviour.

Q13. How Safe do you feel in our Community?

An overwhelming 94.2% (324) replied that they felt safe or completely safe in their community during the day. The corresponding rate after dark was 57.7% (199).

Over three quarters of the respondents, 76.2% (247) cited '*Greater police presence*' as making them feel safer. This was followed by '*better lighting*' (63% or 204) and finally '*CCTV*' (45.4% or 147).

In terms of the 34 open-ended responses, the adequacy of street lighting was emphasised by many, especially at night or during the evening. This corresponds to the previous question on feeling safe in the community. Other issues raised were a greater and more responsive police presence and the need to cut overgrown trees and bushes, which make some people feel unsafe as may shield crime and anti-social behaviour activity.

Q15. Would you participate in a neighbourhood watch scheme?

Of the 343 responses to this question, just under 60% (57.4% or 197) said yes and 42.6% (146) said no.

92.9% (302) stated that it was important or very important that the Parish Council led on '*Activities for elderly and lonely (e.g. Memory café)*', making this the most popular option. It was closely followed by '*Developing and maintaining parks, play areas etc.*' and '*Antisocial behaviour (e.g. litter/dog fouling)*' both 92% (297).

Activities, in order of importance (most to least) were:

- Activities for elderly and lonely (e.g. Memory café) 93%
- Antisocial behaviour (e.g. litter/dog fouling) 91.9%
- Developing and maintaining parks and play areas 91.9%
- Improving community spirit 89.7%
- Activities for young people (e.g. Youth services) 89.4%
- Community projects and events (e.g. litter picks) 88.8%
- Community safety & CCTV 86.9%
- Environmental protection/ climate change initiatives 82.9%
- Bus shelters & community transport 82.4%
- Funding for community groups 81.4%
- Response to emergencies such as adverse weather & pandemics 81.1%
- Promoting wellbeing and fitness 76.1%
- Commenting on planning applications 75.5%
- Flowers, hanging baskets and grounds maintenance 71.4%
- Noticeboards, newsletters and website 67.5%
- Allotments 58.4%

At 58.4% (188) '*Allotments*' had the lowest proportion considering it to be important or very important. It is important to note, however, that this was still higher than those who considered that it was very unimportant or important at 41.6%.

The 19 open-ended responses included the need for a new community hall, more bins and benches and improvements to paths, roads and green spaces. A couple of responses considered that other bodies would be better leading on the identified issues.

The most popular option was '*Christmas/summer fayres*' at 69.6% (213). Next was '*Litter Picks*' 61.4% (188), followed by '*Food Markets*' 59.5% (182). '*Outdoor entertainment (theatre, music)*' and '*Sports events (e.g. community walk/cycling festival)*' were jointly mentioned least 36.6% (112).

There were 32 open-ended responses to this question. Many respondents put forward suggestions for other events such as warm places, environmental activities, police open days, fitness, car boot and arts & crafts. How the existing provision could be improved such as re-opening the community centre; working more closely to provide activities in the centre of Eastleigh and improving community safety so that the people felt safe enough to attend events in the parish was also mentioned. Several suggestions were made on specific groups which any events should focus on, particularly the young and old.

Q18. Please let us know how interested you are in engaging with the following?

At 43% (138) '*The Annual Parish Meeting*' generated the most interest of the three options to this question in terms of those interested or very interested, closely followed by '*Parish Councillor surgeries*' at (41.6% or 131).

There were 14 open-ended comments received on this question. The main themes were:

- Residents would generally like to engage with the Parish Council but face barriers such as work and other pressures that restrict them from doing so.
- Their interest or not to engage is mainly determined by the issue less so by the means of engagement.
- A few suggestions were received about other means the Parish Council might use to engage with residents e.g. email, or the need to target and tailor its engagement activities with specific groups, especially young people.

The most popular option was '*E-mail*' with 46.3% (152) stating that they prefer this means. The next most popular option was '*Printed Newsletter*' at 28.7% (94). '*Social Media*' was the least popular option at 12.8% (42).

Of the '*Other*' 6 open-ended comments received on this question, most supported the use of a newsletter to receive council news and updates.

Provision for '*Babies/Toddlers'* had the highest levels of satisfaction with 62.5% (158) rating its provision as adequate or very adequate. This was followed by 'Young Children' (58.6% or 150) and 'Adults' (52.4% or 145). The provision of activities for 'teenagers' had the lowest level of satisfaction with 54.2% (142) stating that it was inadequate and a further 23.3% (61) that it was very inadequate.

Two thirds of respondents (66.5% or 210) said they would like to see more '*Improved footpaths /lighting'*. This was followed by '*Improved management of open spaces'* (50.6% or 150) '*More litter /dog fouling bins'* (48.4% or 153) and '*Measures to promote wildlife and plant* *diversity*' (46.2% or 146). '*Reduced light pollution*' was the least cited (41 or 12.97%).

Respondents were asked what other they would like to see more. Of the 33 comments received here, the most common themes were:

- A new community hall/meeting offering activities for residents.
- Environmental improvements such as better street cleaning and general maintenance of green spaces.
- Play areas or similar in parks.
- Highway and pedestrian safety measures.

The vast majority considered the provision of the stated '*public realm areas*' to be either good or poor. In percentage terms, the lowest level of satisfaction was with '*Dog Bins*' with 60.4% (or 177 of the 293 respondents to this question) viewing their provision as very poor or poor. This was followed by '*Benches'* with 58% (or 177 of the 305 respondents to this question) also viewing their provision as very poor or poor.

The highest level of satisfaction was with '*Bus Shelters*' with just over half (50.7% or 153) rating them as good or very good.

The 19 open-ended respondents to this question generally either (i) underlined their general support for the provision of one or more of the public realm options, in particular the need for more '*Litter*' or '*Dogs Bins*'

or (ii) identifies specific locations where one of the options should be provided such as Ruskin Road.

Q23. Do you take part in any clubs, hobbies or activities in Boyatt Wood?

Of the 317 respondents to this question 85.2% (270) replied no and 14.8% (47) yes.

There were 51 open-ended comments received on this question. The main themes were that:

- There were no or limited clubs or activities and this limited the extent to which local people could be involved in such activities.
- What activities were available could be better advertised.
- Respondents were involved in clubs, hobbies or activities further afield, particularly Eastleigh.
- Several suggestions were received on new or improved activities/clubs with allotments and walking/running cited most frequently.

With 91.2% (281) stating that they were likely or very likely to support '*Better recycling facilities in the parish*' this scored highest amongst the options. This was followed by '*Introducing bee/butterfly friendly flower planters*' (84.8% or 262) and '*The Parish Council adopting a 'Green Policy'* for all their activities' (81.8% or 252). '*Wildlife Conservation projects'* and '*Increasing wildflower verges/boarders'* also gained over 80% of the respondent's support.

The least popular initiative was '*Public electric charging point installation*'. However, the percentage stating that they were likely or very likely to support it (at 66% or 204) was still nearly double the percentage (34%) stating that they were unlikely to support or very unlikely to support it. 11 open-ended responses were received to this question. Many stressed the need for the stated activities to be prioritised, affordable and if introduced adequately maintained. Some suggestions were made for other initiatives such as in relation to hedgehogs, re-opening of the community centre and improved cycles lanes.

'*Opportunities to meet*' at 73.2% (205) was the most popular service for older people which respondents would like to see in Boyatt Wood. This was followed by '*Advice on support services for older people (drop in surgeries)*' (62.5% or 175) and '*Care /Carer support services*' (56.1% or 157). '*Advice on respite care*' was mentioned least frequently (37.1% or 104).

There were 18 open-ended other comments received on this question, that can be grouped into three main themes:

- That the existing provision was adequate.
- That all services required by older people should be provided.
- Some highlighted other services they would like to see introduced or improved such as access to a doctor, community centre and initiatives to help older people to care for their garden.

The most popular option was '*Youth club/Meeting area*' with just over twothirds (69.2% or 189) stating they would like to see this in Boyatt Wood, followed by '*Events and activities (All ages)*' (65.6% or 179). The least popular of the four options was '*Outreach/advisory services (Sexual health, careers etc)*' with 38.1% (104) supporting this.

There were 17 open-ended comments received on this question. The most common theme here was that they did not know as did not have children or young children or were not familiar with the existing provision of services for children and young people. That there should be more youth workers was highlighted as were more play areas.

Over 80% stated that they agree or strongly agree with the statement that 'I am *satisfied with my local area as a place to live*' (81.4% or 245). A further two-thirds agreed or strongly agreed with the statements that 'I feel that I belong to Boyatt Wood' (68.7% or 206); closely followed by '*If I needed help, there are people who would be there for me*' (66.8% or 201).

Less than half (45.4% or 136) agreed or strongly agreed with the statement '*If I needed to find sources of help locally I know where to find that information*'.

Q28. What three words would you use to describe Boyatt Wood right now?

254 respondents answered this question, which generated 739 words. These words have been analysed and grouped by word. The top ten words (ranked) used to describe Boyatt Word were:

- Friendly (mentioned 40 times)
- Safe (mentioned 34 times)
- Quiet (mentioned 29 times)
- Green (mentioned 25 times)
- Pleasant (mentioned 22 times)
- Convenient (mentioned 17 times)
- Untidy (mentioned 16 times)
- Noisy (mentioned 10 times)
- Run down (mentioned 9 times)
- Home (mentioned 9 times)

Q29. We realise that we might not have captured issues that everyone wants to focus on. If there are other issues or concerns, please list them here.

There were 123 open-ended comments received on this question. As is to be expected with this type of question, it generated a wide and diverse range of comments. The vast majority of the respondents to this question amplified or underlined some of their responses to earlier questions, especially, in relation to concerns about parking, highway safety, potholes and the need for improvements to parks and other green spaces.

In terms of other issues that may have not been fully captured by the survey, several comments were received on the survey itself. That some of the questions may have benefited from a don't know option or the respondent did not have the detailed local knowledge to contribute fully. In addition, a few comments were received about the need develop the distinct identity and community spirit of Boyatt Wood. The 'proliferation' of new telegraph poles was also mentioned by three respondents.
